Metro Housing | Boston mobilizes wide-ranging resources to provide innovative and personalized services that lead families and individuals to housing stability, economic security, and an improved quality of life.



Dear Friends.

Between July 2023 and June 2024, Metro Housing Boston served nearly 14,000 families with federal and state voucher programs that subsidize the rents of low-income families. In addition, more than 9,000 families received eviction prevention aid from the Residential Assistance for Families in Transition (RAFT) program, and more than 900 individuals obtained in-depth case management from our Housing Supports programs.

We are also mindful of the work that lies ahead. The housing crisis in Massachusetts continues to grow. There is not enough housing in the state that is affordable and available to low-income families. Inflation has caused rents to rise, and incomes have not kept up with the steep increases. As a result, more and more residents are seeking assistance, and the Metro Housing Boston staff works diligently to keep up with the demand.

Families need a stable place to live in order to succeed in other areas of their lives, whether it be holding a job, maintaining their health, and/or raising children. Metro Housing Boston recognizes this necessity and offers a variety of programs to address multiple needs.

In FY24, Metro Housing:

- Provided 682 families with stabilization services to ease transition to permanent housing
- **Administered rental assistance** vouchers for 13,986 households
- **Distributed \$37.8 million in RAFT** emergency housing payment assistance
- Matched with 44 participants in long-term financial coaching mentorships via Green Space Financial Coaching program
- Served 1,310 families and individuals through Accountable Care **Organizations Flex Services**
- Conducted 37,286 counseling sessions via the Housing Hub (Housing **Consumer Education Center/HCEC)**
- **Closed 28 Home Modification Loans** valued at **\$700,000**

In April, the Housing Supports team hosted a Household Drive for participants in the HomeBASE program. Staff provided 74 families with "Welcome Home" baskets that included personal hygiene items and basic household essentials like towels; dish soap; pots and pan sets; and flatware.
